**ORDER (Thirteenth hearing) :**

1. This order may be read with the reference of previous order of the Commission dated 22.02.2022 vide which both the parties were present and heard. The PIO-cum-AIGP, BOI Punjab was given one final opportunity to provide the "enquiry report of the complaint filed by the appellant dated 01.05.2018 along with the certified copies of the witnesses recorded" as cited in the RTI application.
2. In today's hearing respondent's representative Ms. Jaswinder Kaur pleaded that requisite information has already been provided to the appellant dated 28.02.2023 vide letter ref. no. 963/- inv 4 and no any other information pertaining to this RTI application is pending in the official record O/o AIGP Pb. On this, Sh. Sunil Kumar Joshi contended that only preliminary enquiry report and statement of the witness Sh. Sanjay Garg recorded has been supplied by the respondent authority so far. Statement of the second witness Sh. Vikramjit Singh and final enquiry record is still pending. Respondent Ms. Jaswinder Kaur on this, reiterated his earlier contention that all the information has already been sent to the appellant and the preliminary enquiry report is the final as no further change was done in the preliminary enquiry report. She further added that there no statements of Sh. Vikramjit Singh has been recorded in this case.
3. **DECISION:** Keeping in view the the facts of the case and after hearing both the parties the Commission directes the PIO to furnish an affidavit within 10 days after receiving the orders providing therein the factual situation (as discussed above) and affirming the position "that the preliminary enquiry report is the final enquiry report and no statements of Sh. Vikramjit Singh has been recorded in this case ".
