## **Appeal Case No. 1794 of 2022**

### **ORDER**

This order may be read with reference to the previous order dated 19.9.2022. The case was earlier heard by the bench of Sh. Sanjiv Garg, SIC but due to administrative reasons the case was reallocated to this bench and fixed for hearing on 9.11.2022. But the case could not be heard on the said date and further adjourned for today.

2. The appellant has sought the following information as per his RTI application:-

“1) ਇਹ ਹੈ ਕਿਧਾਰੀਵਾਲ ਅਧੀਨ ਪੰਚਾਇਤਾਂ ਨੂੰ ਪਿਛਲੇ 5 ਸਾਲਾਂ ਦੌਰਾਨ ਜੋ ਗ੍ਰਾਂਟਾਂ ਪ੍ਰਾਪਤ ਕੀਤੀਆਂ ਹਨ ਉਹਨਾਂ ਦਾ ਵੇਰਵਾ ਅਤੇ ਪੰਚਾਇਤ ਸੈਕਟਰੀਆਂ ਦੇ ਨਾਮ ਅਤੇ ਸਰਪੰਚਾਂ ਦੇ ਨਾਮ ਦੱਸੇ ਜਾਣ।

2) ਬਲਾਕ ਧਾਰੀਵਾਲ ਅਧੀਨ ਬੀਡੀ ਪੀਓ ਦੀ ਹੱਦਬੰਦੀ ਅੰਦਰ ਜੋ ਪ੍ਰਾਪਤੀ ਜਾਂਦੀ ਹੈ ਉਸਦਾ ਵੇਰਵਾ ਅਤੇ ਹਨ ਜਾਂ ਨਹੀਂ (ਠੇਕੇ) ਤੇ ਹਨ ਉਹਨਾਂ ਦਾ ਵੇਰਵਾ ਦਿੱਤਾ ਜਾਵੇ।

3) ਬਲਾਕ ਧਾਰੀਵਾਲ ਅਧੀਨ ਪੰਚਾਇਤਾਂ ਦੇ ਪਿਛਲੇ ਪੰਜ ਸਾਲਾਂ ਦੌਰਾਨ ਕਰਵਾਏ ਗਏ ਆਡਿਟ/ਅੰਦਰੂਨੀ ਪੜਤਾਲ (ਵਿੱਤ ਵਿਭਾਗ) ਦੀਆਂ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ।

3. The appellant is absent without intimation. However, the representative of the respondents submits that the complete information will be sent to the appellant through registered post within two days and requested to close the case. The representative

of the respondents further tender unconditional apology and made the oral submissions to withdraw the show cause notice issued to the Public Information Officer in this case. After hearing the oral submissions made by the respondent, the show cause notice issued to the respondent-Public Information Officer in this case is hereby withdraw.

4. The similar information has been sought by the appellant from the different block in which it has transpired that the information pertaining to the name of villages, action plan, asset details, execution status and details of Panchayat Secretaries/Sarpanches etc. Are also available on the website of the Department i.e. [www.pbrdp.gov.in](http://www.pbrdp.gov.in). In addition, the information related to Panchayat Profile, Plans and Financials are also available at [www.egramswaraj.gov.in](http://www.egramswaraj.gov.in).

5. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed. However, the appellant is at liberty to approach the Commission within two weeks in case he does not receive the same or he has any submission to make in this case.
