ORDER

- 1. This case may be read with the reference to the previous order dated 03.10.2022
- 2. The case has been heard today in the Commission's office at Chandigarh. Shri Surinder Singh, Gram Rozgar Sewak states that they called Shri Prem Singh, appellant on 13.10.2022 to their office and clarified issues related to the information sought including inspection of case related documents. The appellant however refused to take the information with him by hand, so the information was sent to the Appellant by registered post on 14.10.2022.
- 3. On the asking of the Bench, Shri Prem Singh shows the envelope which was sent by the department. The appellant states that he requires the information in Punjabi language and certain documents have been provided are in English and Hindi. It is clarified to the appellant that certain instructions / policy issues are in English and have been provided as such. It also emerges during deliberations that information on point number 1 of RTI application is still pending.
- 4. On asking about point number 1, Shri Surinder Singh, GRS states that enquiry is still in progress and related details will be provided to Shri Prem Singh, appellant on completion of enquiry.
- 5. Post deliberations, the Bench finds that point wise information has been supplied to Shri Prem Singh, appellant. The information relating to point number 1 will be supplied by the PIO concerned once the enquiry is completed. So, no further cause for intervention is left in this case.
- 6. With the aforesaid directions, **this case is disposed of and closed**. Copies of the order be sent to the concerned parties.
