ORDER:

- 1. This order may be read with reference to the previous order dated 05.04.2023 vide which it was observed that information in connection with point no.2 & 3 was still to be supplied. Respondent PIO was absent on the previous hearing even after issuing him show cause notice (vide order dated 03.01.2023). Accordingly, penalty amounting Rs.5,000/- was imposed on the concerned respondent PIO. Matter was adjourned to 30.5.2023.

- 5. On hearing held on 05.04.2023, penalty amounting Rs. 5,000/- was imposed on respondent PIO and compliance report is still not received by the Commission.
- In wake of above, Penalty amounting Rs. 5,000/- which was imposed on the concerned respondent PIO, O/o Secretary, Regional Transport Authority, Faridkot vide order dated 03.01.2023 passed by the undersigned Bench is enhanced toRs. 10,000/-
- 7. The Drawing and Disbursing Officer of the office of Secretary, Regional Transport Authority, Faridkot is directed to deduct the amount of penalty of Rs. 10,000/- from the salary of the concerned respondent PIO and be deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-
