<u>ORDER</u>

- 1. This order may be read with the reference to the previous order dated 17.10.2022. On the previous hearing, the Bench directed the PIO to supply the information to the Appellant and to pay the amount of compensation of Rs. 5000/- to the appellant by cheque or demand draft from the account of public authority as also to file reply to the show cause notice before the next date of hearing.
- 2. The case has been heard today in the Commission's office at Chandigarh. Shri Jang Bahadur, appellant is absent but a letter dated 10.11.2022 as well as a telephonically message (today) has been received by the Bench in which he has mentioned that neither information nor compensation has been received by him.
- 3. Shri Rakesh Kumar, Clerk states that Shri Sanjeev Sharma (Secretary) has gone to meet Shri Jang Bahadur, appellant today for supplying the information and clarifying the facts of this case.
- 4. Post deliberations and after going through the case file and the documents placed on record, the Bench directs the PIO O/o DDPO, Fazilka to appear in person on the next hearing before the Bench with the attested copies of requisite information, reply to show cause notice and produce an evidence of having paid the compensation amount to the appellant, failing which Baiable Warrant will be issued again in the name of PIO and departmental enquiry will also be recommended against PIO on the next hearing.
- 5. With the aforesaid directions, the matter is adjourned. Both the concerned parties are directed to attend the hearing on 12.12.2022 at 11.30 am before the Bench at Punjab State Information Commission, Madhya Marg, Sector 16, Chandigarh. Copies of the order be sent to the concerned parties.
