He also submits that the information pertaining to the name of villages, action plan, asset details, execution status and details of Panchayat Secretaries/Sarpanches are available on the website of the Department i.e. www.pbrdp.gov.in. Since, the appellant is absent without intimation, therefore, the directions are issued to the respondent-Public Information Officer to send the same to the appellant as they have prepared the information through registered post. The representative of the respondents further tender unconditional apology and made the oral submissions to withdraw the show cause notice issued to the Public Information Officer in this case. After hearing the submissions made by the respondent, the show cause notice issued to the respondent-Public Information Officer in this case is hereby withdrawn.

4. Keeping in view the above the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed. However, the appellant is at liberty to approach the Commission within two weeks in case he has any submission to make for the consideration.
