#### ORDER

This order may be read with reference to the previous order dated 6.9.2022. The case was earlier heard by the bench of Sh. Sanjiv Garg, SIC but due to administrative reasons the case was reallocated to this bench and fixed for hearing on 2.11.2022. But the case could not be heard on the said date and further adjourned for today.

2. The appellant has sought the following information as per his RTI application:-

- 1) ਇਹ ਹੈ ਕਿ ਸੁਧਾਰ ਬਲਾਕ ਅਧੀਨ ਗ੍ਰਾਮ ਪੰਚਾਇਤਾਂ ਨੂੰ ਪਿਛਲੇ 5 ਸਾਲਾਂ ਦੌਰਾਨ ਜੋ ਗ੍ਰਾਂਟਾਂ ਗ੍ਰਾਮ ਪੰਚਾਇਤਾਂ ਨੂੰ ਦਿੱਤੀਆਂ ਗਈਆਂ ਹਨ ਉਹਨਾਂ ਦਾ ਵੇਰਵਾ ਅਤੇ ਪੰਚਾਇਤ ਸੈਕਟਰੀਆਂ ਦੇ ਨਾਮ ਅਤੇ ਸਰਪੰਚਾਂ ਦੇ ਨਾਮ ਦੱਸੇ ਜਾਣ।
- 2) ਸੁਧਾਰ ਬਲਾਕ ਅਧੀਨ ਬੀਡੀਪੀਓ ਦੀ ਹੱਦਬੰਦੀ ਅੰਦਰ ਜੋ ਪ੍ਰਾਪਰਟੀ ਜਾਂ ਦੁਕਾਨਾਂ ਕਿਰਾਏ ਤੇ ਹਨ ਜਾਂ ਲੀਜ਼ (ਠੇਕੇ) ਤੇ ਹਨ ਉਹਨਾਂ ਦਾ ਵੇਰਵਾ ਦਿੱਤਾ ਜਾਵੇ।
- 3) ਬਲਾਕ ਸੁਧਾਰ ਅਧੀਨ ਪੰਚਾਇਤਾਂ ਦੇ ਪਿਛਲੇ ਪੰਜ ਸਾਲਾਂ ਦੌਰਾਨ ਕਰਵਾਏ ਗਏ ਅਡਿਟ/ ਅੰਦਰੂਨੀ ਪਤਰਾਲ (ਵਿੱਤ ਵਿਭਾਗ) ਦੀ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ।

3. The appellant is absent without intimation. However, the representative of the respondents submits that the information has already been sent to the appellant through registered post. He also submits that the Commission has already been informed and a copy of the postal registered receipt was also sent along with the

intimation letter. In addition, he also submits that no deficiency has been received from the appellant till date. The similar information has been sought by the appellant from the different block in which it has transpired that the information pertaining to the name of villages, action plan, asset details, execution status and details of Panchayat Secretaries/Sarpanches are available on the website of the Department i.e. [www.pbrdp.gov.in](http://www.pbrdp.gov.in). The representative of the respondents further tender unconditional apology and made the oral submissions to withdraw the show cause notice issued to the Public Information Officer in this case. After hearing the submissions made by the respondent, the show cause notice issued to the respondent-Public Information Officer in this case is hereby withdrawn.

4. Keeping in view the above, the Commission is of the view that no further action is required to be taken in this case as neither the appellant is present nor any deficiency has been received from him. Hence, the case is disposed of and closed.
