<u>ORDER</u>

1. This order may be read with reference to the order dated 01.09.2022 passed by this Bench on the previous hearing.

2. The case has been heard today. Shri Amarjit Singh Dhamotia, appellant comes present to attend the hearing through cisco webex. He states that he has not received any information.

3. Shri Manpreet Singh Minhas, SDO and Shri Nazam Singh, Steno Sub Division, PSPCL, Janta Nagar, Ludhiana come present to attend the hearing in person before the Bench. The respondent states that letter regarding RTI application of the appellant has been received only a day prior by the PIO. He further states that the appellant has sought information regarding not disconnecting the electricity connection in the illegal colony Shiva Enclave. He further states that similar information was sought by the appellant in another Appeal Case No.851, in which he has been supplied information vide letter dated 28.07.2022 and also produces the said letter before the Bench which is taken on record. He also states that release of connection to illegal colonies, without production of NOC, have been stopped.

4. The Bench apprises the appellant of the version of the representative of the PIO and also directs the PIO PSPCL Janta Nagar Division, Ludhiana to supply point wise information to the appellant in this appeal case also under intimation to the Commission.
