ORDER

1. This order may be read with the reference to the order dated 10.11.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Krishan Lal Rinwa, attends the hearing through cisco webex and states that he has submitted deficiencies to the PIO as well as to the Hon'ble Commission stating that information on Point No.2, 3, 4 and 5 is still pending.
3. Shri Vikrant, Clerk O/o ADC (Dev.), Fazilka and Shri Gian Singh, Panchayat Secretary, Gram Panchayat, Bareke, District Fazilka come present to attend the hearing on behalf of the Respondent / PIO in person before the Bench. Shri Vikrant states that point wise information has been supplied to the appellant vide letter dated 07.10.2022 and that nothing beyond the information supplied is available in the official records. The appellant is apprised of the version of the respondent. He, however, is not satisfied with the reply of respondent and contends that shortcomings have been sent to the PIO.
4. Post deliberations, the Bench directs the PIO O/o ADC (Dev.), Fazilka to address the shortcomings pointed out but the respondents state that all documents have been shown to the appellant and nothing beyond what has been sent is available in official records. The PIO, in view of the submissions made by the respondent, is now directed to file an affidavit on e.stamp paper within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.1952/2021 has been supplied to the appellant. It be further stated that nothing has been concealed therein and the statement made is true and correct. Original affidavit be sent to the appellant and copy be sent to the Commission for record.
5. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
