**ORDER**

1. The RTI application dated 6.12.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 16.01.2023 and second appeal was filed in the Commission on 20.03.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing for 13.6.2023 through CISCO WEBEX application.
2. In today's hearing both the parties are present.
3. The appellant states that he has sought information vide his RTI application on 6.12.2022 but the same has been denied.
4. The respondent states that reply was sent to the appellant on 14.12.2022 stating therein that demanded information does not relate with the respondent office along with IPO.
5. After examining the documents placed on record, it is observed that appellant filed RTI application to the respondent office i.e. Punjab state Board of Technical Education & Industrial Training, Chandigarh on 06.12.2022 and he filed first appeal to the office of Director, Punjab State Board of Technical Education & Industrial Training, Chandigarh on 11.01.2023.
6. As per the case file received from the Registry Branch of the Commission; First Appellate Authority is mentioned in this instant appeal case is Director, Punjab State Board of Technical Education & Industrial Training, Chandigarh. A copy of this order be sent to FAA through registered post along with RTI application for his ready reference. First Appellate Authority is directed to submit reply in this regard and represent this case on the next date of hearing positively.
7. It is also observed that appellant has not mentioned the time period for the demanded information in RTI application. On this, appellant states that he will send time period within one week to the Commission.
8. With aforesaid observations/directions, matter is adjourned for further hearing on **26.07.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application).
