- 1. The RTI application dated 5.9.2022 vide which the appellant has sought information as enumerated in his RTI application. Accordingly, respondent PIO is directed to send information again to the appellant within seven days after collecting from the concerned office/branch
- 7. Appellant is advised to go through the information, once he had received and point out ambiguity within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
