1. The RTI application is dated **19.1.2021** vide which the appellant has sought information as under:-

ਉਹਨਾਂ ਦੀ ਤਸਦੀਕਸ਼ੁਦਾ ਸੂਚੀ ਜਾਂ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ ।

enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **17.2.2022**, and Second Appeal was filed in the Commission on **20.4.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **18.8.2022**.

2. The appellant is absent without intimation. The respondent PIO-cum-Superintendent, office of SDM, Nakodar, has sent a reply to this Commission's Notice of Hearing vide Letter No. 931 Dated 8.8.2022, wherein it is stated that a reply was sent to the appellant in time on 23.2.2022, informing him that there was no separate list or record available for 'fancy numbers' in her office. The appellant was also informed that if he wanted information about any specific numbers, he could make a request to check its availability from the office.

3. In view of the above, the Commission is satisfied that the respondent PIO has provided an adequate reply to the RTI application within the time period stipulated by the RTI Act. This Appeal is accordingly **Disposed of**.
