**ORDER**

1. This order may be read with reference to the order dated 31.08.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Yogesh Mahajan, appellant has not come present to attend the hearing in person before the Bench or through cisco webex. He has informed through a telephonic message that he is unable to attend the hearing and has requested for another date.
