ORDER

1. This order may be read with reference to the order dated 01.09.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Amarjit Singh Dhamotia, appellant comes present to attend the hearing through cisco webex. He denies receipt of information.
3. Shri Amit Yadav, SDO, PSPCL Sahnewal comes present in person before the Bench and states that the appellant has been sent reply vide letter dated 07.10.2022 stating that vide letter of GLADA referred to in RTI application, no order has been received from GLADA for disconnection electricity power connection of any particular area, colony or consumer and that as per PSPCL's commercial circular No.19/2017, there is exemption from NOC/CLU to apply for any connection. He further states that they have written to office of GLADA a number of times to intimate the list of unauthorised colonies which has not been received from GLADA so far. He further states that copies of Electricity State Instructions Manual and Commercial Circular No.19/2017 have been sent to the appellant and also produces a copy of the letter dated 07.10.2022 before the Bench which is taken on record. The appellant is apprised of the version of the SDO Sub Division, PSPCL Sahnewal.
4. Post deliberation, the Bench directs the PIO to get necessary information from GLADA and supply the information as available in official records to the Appellant along with a copy to the Commission before the next hearing. He is also directed to file reply to the show cause notice.
5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 10.11.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
