ORDER:

1. The RTI application is dated 24.12.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.01.2021 and the second appeal was filed in the Commission on 05.07.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. This case was earlier allocated to Hon'ble SIC Amrit Partap Singh Sekhon and has been re-allocated to this Bench vide order dated 06.10.2022. The notice of hearing was issued to the parties for 16.11.2022. Accordingly, the case has been heard today.
3. Shri Jiwan Garg, appellant has not come present to attend the hearing either in person or through cisco webex. He has, however, sent an e.mail dated 15.11.2022 stating therein that he has received partial information on 14.11.2022 and that information on point Nos.5,6,7,15,16,17 & 18 is still pending. He has also requested for adjournment to another date as he wants to go through the information provided to him.
4. Shri Kuldip Singh, RTI Assistant O/o SSP Sangrur attends the hearing through cisco webex and states that information sought on 19 points has been supplied to the appellant on 14.11.2022 by e.mail and that the appellant is also satisfied with the information supplied.

5. The Bench apprises the respondent the version of the appellant as per his e.mail received by the Bench. The PIO O/o Sr. Superintendent of Police, Sangrur is directed to supply balance information to the appellant on point Nos.5,6,7,15,16,17 & 18 as also reply to the letter dated 06.09.2022 of the appellant as referred to in his e.mail and ensure to come present in person before the Bench on the next date of hearing.

6. The appellant is also directed to come present in person before the Bench on the next date of hearing, failing which the Bench will decide the appeal case on the basis of documents available in case file.

7. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 12.12.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
