**ORDER:**

1. The RTI application is dated 12.01.2023 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.02.2023 and the second appeal was filed in the Commission on 24.03.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today. The appellant states that only partial information has been supplied to him by the respondent so far.
3. The respondent states that appellant filed a complaint bearing UID No. 73463RTI before the SSP, Ferozepur on 24.11.2022 and has sought information in this regard on 12.01.2023 by the way of filling RTI application on five points. He further adds that RTI application of the appellant was received in their office on 16.01.2023 and reply to this effect has been sent vide letter dated 08.02.2023 that inquiry is under process, hence the information cannot be supplied under Section 8(i)(h) of the RTI Act as it will effect the outcome of the inquiry. Subsequently, the appellant filed first appeal before the first appellate authority and in the meanwhile inquiry was completed and final report of the inquiry along all the supporting documents which were asked for by the appellant in his RTI application has been supplied to him vide letter dated 02.03.2023. Copy of the same is taken on record.
4. On asking of the Bench, the appellant states that he has received a copy of inquiry report but information on point no. 5 has not been given.
5. Post deliberations, the Bench examines the documents and observes that respondent has addressed all the points as raised by the appellant in the RTI application. The appellant has not sought any document in point no.5 but has raised a question which is query and hence has correctly not been responded to.
6. Since, the information as per official records stands supplied, no further cause of action is left in the instant appeal case. The case is **disposed off and closed**. Copies of the order be sent to the parties.
