- 2. Both parties are present. The respondent PIO is represented by Smt. Kulwinder Kaur, Building Inspector, MC, Amritsar. At the last hearing on 2.12.2022, the Commission had **impleaded Deputy Commissioner, Amritsar, Sh. Harpreet Singh Sudan, IAS**, in this Appeal Case with the direction to submit a report in compliance of this Commission's Orders Dated 11.8.2022 and 31.5.2022 within 10 days of receipt of the Order of 2.12.2022.
- 3. The Deputy Commissioner, Amritsar, has failed to comply with the Commission's directions. This matter pertains to very serious allegations regarding the authenticity of an affidavit submitted to this Commission by the Municipal Town Planner-cum-PIO, Sh. Iqbal Preet Singh Randhawa. DC, Amritsar, Sh. Harpreet Singh Sudan is given one more opportunity to comply with this Commission's direction at para 3 of the Commission's Order of 2.12.2022 and submit a copy of his report to the Commission as well as the appellant Smt. Kamaldeep Kaur. This must be done within 10 days of receipt of this Order.
- 4. This Appeal is accordingly **Disposed of.**
