**ORDER:**

1. The RTI application is dated 05.12.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 23.01.2023 and the second appeal was filed in the Commission on 27.03.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The case has been heard today. The appellant is absent for today's hearing without any intimation to the Bench.

3. The respondent states that reply has been sent to the appellant vide letter dated 23.05.2023 comprising seven pages by registered post. Copy of the same is taken on record.

4. The appellant is contacted on his mobile phone. He is apprised the version of the respondent but denies receipt of information till date. He states that he is presently residing in Rajasthan but copy of information has probably been sent to his Abohar address. The notice of hearing of the Bench has also been received back undelivered.

5. The Bench examines the copy of reply sent by the respondent to the appellant and finds it in order. Copy of the information which has been submitted by the respondent today be sent to the appellant on the Abohar address, which has given by the appellant during interaction on mobile with him.

6. Since, the information as per RTI application of the appellant has been supplied, no further cause of action is left in the instant appeal case. The case is **disposed off and closed**. Copies of the order be sent to the parties.
