ORDER:

- 1. The RTI application is dated 10.07.2022 vide which the appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.09.2022 and the second appeal was filed in the Commission on 02.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
- 2. The notice of hearing was issued to the parties for 28.02.2023. Accordingly, the case has been heard today. Shri Rahul Dev Singh comes present in person before the Bench to attend the hearing on behalf of the appellant Sanjeev Thakur. He states that no information has been provided to the appellant.
- 3. Shri Himanshu Verma, SDO, Shri Ashok Kumar, Supervisor, Personnel Division, and Shri Karan Singh, SDO, Township Division, O/o R.S.D. Shahpur Kandi Township come present in person before the Bench to attend the hearing on behalf of the PIO. Shri Ashok Kumar states that the appellant has sought information about one Harbhajan Singh, SDO, Township Division, RSD Shahpur Kandi and his RTI application was transferred to PIO, Township Division who has submitted point-wise reply to the RTI application. As per his reply, the appellant has been informed vide letter dated 10.08.2022 stating that the information sought by him is personal and third party information and the said Harbhajan Singh has also made written submissions refusing consent to share information about him being personal and third party.

The Bench observes that reply form PIO/Dams-cum-Personnel Division No.II, Shahpur

respondents also make mention of the judgment of Hon'ble Supreme Court in Civil Appeal No.10044 of

2010 titled as Central Public Information Officer, Supreme Court of India vs. Subhash Chandra Aggarwal,

based on which the Govt. of Punjab has issued instruction vide letter dated 09.08.2021 detailing therein

the matters which constitute personal and third party information and the same is protected from sharing

with general public.

5. On perusing the reply, the representative of appellant contends the version of the

respondents and alleges that the said officer Shri Harbhjan Singh does not fulfil the qualification for the

post of SDO and he has managed to secure job by playing fraud and as such, the appellant has sought

qualification certificates of the said officer.

6. The Bench peruses the Govt. instructions dated 09.08.2021 and also hears the version of

the respondents and the representative of appellant. The Bench though agrees with the contention raised

by the respondents, but in view of the submissions made by the representative of appellant, directs the

PIO to provide copies of educational certificates of the said Harbhajan Singh before next hearing.

However, the copy of service book which contains personal and official details, be withheld.

7. The PIO is also directed to ensure to come present in person before the Bench on the

next date of hearing.

8. With the aforesaid directions, the matter is adjourned. To come up for hearing on

04.05.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh. Copies of the order

be sent to the concerned parties.
