**ORDER:**

1. The RTI application is dated 01.12.2022 vide which the appellant has sought information as enumerated in her RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 30.01.2023 and the second appeal was filed in the Commission on 28.03.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today. As per respondent, the appellant has sought videography /recording done during the course of enquiry conducted by the enquiry committee on the complaint of the appellant and the information/reply has been provided to the appellant vide letter dated 19.12.2022 and 03.05.2023 through registered post. The respondent further states that since the information sought relates to an enquiry, it can be got from the enquiry officer conducting the enquiry under MC Abohar.
3. The appellant is absent. The appellant is contacted on his mobile and he states that no information has been received by him.
4. The PIO is directed to procure the information from the concerned enquiry officer and provide it to the appellant before the next hearing. The PIO is directed to come present in person before the Bench to attend the next hearing. The appellant is also directed to come present in person before the Bench on the next date of hearing failing which the Bench may be constrained to decide the case based on the documents available on record.
5. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 28.06.2023 at 11.30 AM before the Bench in Commission's Office at Chandigarh.** Copies of the order be sent to the concerned parties.
