**ORDER:**

After inspection of records by the appellant, the information as is identified by the appellant be provided to him before the next hearing.

The PIO is directed to ensure that official records related to RTI application of the appellant are presented for examination and documents as identified are given duly attested by the PIO. The PIO is also directed to come present in person before the Bench to attend the next hearing.
