ORDER:

1. The RTI application is dated 30.08.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 04.10.2022 and the second appeal was filed in the Commission on 02.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Shri Milan, appellant is absent. He has however sent an email vide dated 22.02.2023 to the Bench through which he has requested for an adjournment and further mentioned that no information has been received by him yet.
3. Shri Raj Kumar Bansal, PIO O/o PUDA states that the RTI application relates to the office of GLADA and has been transferred to them under Section 6 (3) of the RTI Act.
4. Shri Sumit, Senior Assistant from GLADA office states that no such complaint comprising of Grievance ID: 20220109304 dated 03.06.2022 has been received by their office yet.
5. Post deliberations, the Bench directs the PIO to submit the same in writing signed by the PIO and send it to the appellant along with a copy to the Bench. The appellant is advised to provide a copy of the complaint to the office of GLADA on priority.
6. The PIO and Shri Milan, appellant are directed to appear in person on the next date of hearing before the bench.
7. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 26.04.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
