In view of the above, a <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the Public Information Officer cum Block Development & Panchayat Officer, Block Ludhiana-I, District Ludhiana to explain as to why penalty should not be imposed upon him/her for wilful delay/denial in supplying the information to the RTI appelant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
- 6. <u>LAST & FINAL OPPORTUNITY</u> is given to the PIO to file reply to the Show Cause Notice and provide complete information to the appellant within week, under intimation to the Commission and should appear personally in the Commission, on the next date fixed, failing which Rs. 25000/- penaly will be imposed upon him/her as per provisions of the RTI Act, 2005.
- 7. The District Development and Panchayat Officer, Ludhiana is also directed to ensure compliance of the order from the concerned PIO, before the next date of hearing.
- The matter is adjourned. To come up for hearing on 19.04.2023 at 11:30 AM in the Commission. Both the parties are directed to present their case personally. Copies of the order be sent to the parties.
