**ORDER**

1. The RTI application is dated 26.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 27.10.2022 and second appeal was filed in the Commission on 19.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 3.5.2023 i.e. today.
2. In today's hearing, both the parties are present.
3. The representative of the appellant states that department denied information to provide while taking plea that the information relates to 3<sup>rd</sup> party. He further adds that information sought for is not 3<sup>rd</sup> party. He requests the court for suitable directions.
4. The respondent states that black and white map had already been supplied to the appellant and colored map of the scheme launched by the Improvement Trust; Bathinda shall be supplied to the appellant. He further adds that no NOC has been issued after the order of the Hon'ble Supreme Court.
5. After hearing both the parties and examining the case file, respondent PIO is directed to supply the colored map along with affidavit in original duly attested by the concerned respondent PIO stating therein that no NOC is issued to anybody after the order of the Hon'ble Supreme Court to the appellant with a copy to the Commission within ten days after receipt of this order.
6. With the aforesaid directions, this instant appeal case is **disposed of & closed**. Announced in the Court. Copies of this order be sent to the parties.
