ORDER

- 4. The respondent, Ms. Kulwinder Kaur states that information was sent to the appellant by e-mail yesterday i.e. 23.01.2023. She further adds that copy of the information is with her, after hearing the same shall be provided to the appellant by hand.
- 5. In view of above, the court advises the appellant to get noted the deficiency, if any, to the respondent within 7 days, failing which it shall be presumed that the information supplied is sufficient and nothing is stated to be deficient. In that situation the case shall automatically be disposed on the next date of hearing.
