**ORDER:**

1. The RTI application is dated 12.02.2023 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.02.2023 the second appeal was filed in the Commission on 03.04.2023 Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for today.
2. In today's hearing, the appellant, Sh. Arun Bansal states that incomplete information has been supplied to him. He further adds that that he is not satisfied with the supplied reply vide letter dated 13.06.2023.
3. The respondent Ms. Sukhjinder Kaur states that information as per official record has already been supplied to the appellant. She further explains the reply as per RTI application.
4. After going through the case file and discussing with
5. both the parties, the PIO concerned is directed to look into this matter thoroughly and make sure to supply the information to the appellant again within 15 days from today as per RTI Act, 2005 along with a copy to the Commission through email positively.
6. The Appellant, Sh. Arun Bansal is directed to go through the supplied information (once received) and point out deficiencies in writing, if any, to the Respondent PIO through registered post/email, with a copy to the Commission, failing which it will be presumed that he has nothing to say and the case would be decided on merits.
7. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
8. With the aforesaid directions, the matter is adjourned for further hearing on **08.08.2023 at 11:00 A.M. through CISCO-Webex**. Copy of the order be sent to the parties. (Steps to use CISCO WEBEX: Install CISCO Webex->Click on Join Meeting->Enter Meeting Number 1582933632).
