## ORDER:

- The RTI application is dated 05.01.2023 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.02.2023 the second appeal was filed in the Commission on 03.04.2023 Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and the hearing has been fixed for today.
- 2. In today's hearing, the appellant, Sh. Narinder Paul Singh states that incomplete information (upto 30<sup>th</sup> April 2021) has been supplied to him. He further adds that he has sent a reply through letter dated 12.06.2023 via email dated 13.06.2023 to the undersigned Bench, which is received and taken on record.
- 3. The respondent Dr. Vivek Talwar states that the concerned person is on medical leave and further states that the personal information cannot be supplied to the appellant relates with third party. He also adds that third party denied disclosing his information with the appellant and copy of supplied information had already been sent to the undersigned Bench on 01.06.2023, which is received and taken on record.
- 4. After going through the case file and discussing with both the parties, I am of the view that the <u>PIO concerned is directed to supply the complete information as per RTI application (from 01 April 2010 to 30 November 2022) as mentioned within 15 days from today as per RTI Act, 2005 under intimation to the Commission.</u>
- 5. Appellant, Sh. Narinder Paul Singh is advised to go through the information, once he had received and point out ambiguity within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
- 6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
