## **Appeal Case No. 2226 of 2022 (Video Conference Proceedings)**

2. The appellant is absent. The respondent PIO has submitted copies of replies sent to the appellant vide Letter No. 58 Dated 14.3.2022 and No. 79 Dated 4.11.2022 (both registered post), wherein the appellant was informed that the matter cited in the RTI application was still under investigation, whereby the request for information was denied as per Section 8(1)(h) of the RTI Act, 2005.
