

Notice was issued to the parties for first hearing in the Commission on **11.11.2022**.

- 2. The appellant is absent. The respondent PIO, represented by Gurjeet Singh, JDM from Zone A, Ravinder Singh Walia, Draftsman from Zone B, Ms. Kashish Garg, Building Inspector from Zone C, and Naresh Kumar, Clerk from Zone D, have submitted copies of replies sent to the appellant from each respective zone. The APIO, office of MTP, has also submitted copy of Letter No. 196 Dated 27.9.2022, along with all earlier replies and information sent to the appellant and information pertaining to the Head Office.
- 3. The Commission has examined said replies and is of the view, that this adequately addresses the RTI application.
- 4. The appellant is strongly advised that all future RTI applications must be submitted to individual PIOs, zone-wise. He must note that all branches of MC, Ludhiana, including Building Branch have zone-wise PIOs and single RTI application to the PIO-cum-Commissioner, MC, Ludhiana, pertaining to all Zones should not be entertained in future. The office of the PIO, Commissioner, Municipal Corporation cannot be expected to serve as a post office.
