ORDER

1. This order may be read with reference to the order dated 21.09.2022 passed by this Bench on the previous hearing as the hearing scheduled for 31.10.2022 was postponed..
2. The case has been heard today. Shri Prem Kumar Rattan, appellant has not come present to attend the hearing in person before the Bench or through cisco webex. However, a letter dated 28.10.2022 of the appellant pointing out deficiencies is available in the case file.

He states that the appellant visited their office on 21.10.2022 and requisite information has been supplied to him.
