ORDER:

1. The RTI application is dated 06.12.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 10.01.2023 and the second appeal was filed in the Commission on 05.04.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The case has been heard today. As per respondent, the information/reply has been provided to the appellant vide letter dated 27.12.2022 and 20.06.2023 through registered post and a copy of same has been sent to the Commission. The respondent further states that matter relates to a complaint filed by the appellant on 26.11.2022 against unauthorised colony namely Amrit Enclave under the jurisdiction of Zone-C, Ludhiana, the complaint was sent to the Municipal Corporation Ludhiana for enquiry vide letter dated 02.12.2022. Details related to this have been conveyed to the appellant however no enquiry report has been received from M.C.Ludhiana yet.
3. The appellant has not come present either in person or through cisco-webex.
4. Having gone through the RTI application and reply of the PIO, the Bench finds that the RTI application has been sufficiently replied to and no further interference of the Bench is needed. A copy of reply received from the PIO be sent to the appellant alongwith the order also.
5. The case is **disposed off and closed**. Copies of the order be sent to the concerned parties.
