ORDER

1. This order may be read with reference to the order dated 23.08.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. The complainant has not come present in person and has informed the Bench that due to health reasons, his submissions may please be heard on mobile.
3. Shri Ravinderpal Singh, Revenue Accountant, South Sub Division O/o PSPCL, Amritsar comes present to attend the hearing in person before the Bench and produces before the Bench authority letter to attend the hearing. He also produces before the Bench letter dated 07.10.2022 supported by the relevant pages of register showing the date of applying for temporary electricity connection in respect of SCO No.46, District Shopping Complex, B Block, Ranjit Avenue, Amritsar on 16.04.1999 and date of installation of service connection on 30.04.1999, as per Entry No.19768. The same is taken on record.

The complainant is contacted on mobile phone and is made to talk to the representative of PIO who apprises the complainant of the documents found relating to his RTI application and entries regarding applying for temporary connection and installation of the same having been located. However, the representative of PIO is unable to give the date when this temporary connection was disconnected.
