## **APPEAL CASE NO. 5287 OF 2022** **(Cisco Webex Proceedings)**

### **ORDER (FIRST HEARING):**

1. The RTI application is dated 07.07.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 17.08.2022 and Second Appeal was filed in the Commission on 03.11.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 22.05.2023.
2. The Representative of the Appellant states that information sought has not been provided to him.
3. The Respondent states that some more time be given him to supply requisite information to the appellant and he will supply the same to the appellant within week.
4. In view of the above, the Appellant is advised to send deficiencies, if any, in writing to the PIO when he receiving information. The PIO is also directed to remove the deficiencies, if any, received from the appellant and supply rectified information, under intimation to the Commission, before the next date of hearing. In case information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which strict action will be initiated against the PIO as per provisions of the RTI Act, 2005.
5. The matter is adjourned to **27.06.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645**. Both the parties are directed to come to attend the hearing accordingly. Copies of the order be sent to the parties.
