## **ORDER** (FIRST HEARING):

- 1. The RTI application is dated 04.06.2022 vide which the Appellant has sought information as enumerated in his RTI application. In case information as sought by the appellant is not available in the official records, then PIO is directed to file an <u>Undertaking</u> in this regard and produce the same before the Bench, on the next date of hearing, failing which strict action will be initiated against the PIO as per provisions of the RTI Act, 2005.
