2. Both parties are present. The respondent PIO-cum-DRO, Sh. Jashandeep Singh, states that the requested record is not available and the appellant has been informed regarding the same not only in this Appeal Case, but also earlier in Appeal Case No. 3209 of 2021 and 3210 of 2021. The appellant however, states that the aforesaid Appeal Cases were Disposed of by the Bench of Ld. SIC Sh. Avtar Singh Kaler, since he was absent from two separate hearings.
