- 3) Copy of document related with final assistance by Direct Benefit Transfer (DBT) paid to concerned firm from which Machinery was purchased by SAABCHAKIA WELFARE SOCIETY.

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **17.3.2021** and Second Appeal was filed in the Commission on **18.5.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **23.9.2022**.
