**ORDER**

8. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
9. With the aforesaid directions, the matter is adjourned. Both the parties are directed to come up on **03.08.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application).
