## ORDER

- 1. This order may be read with reference to the previous orders dated 07.09.2021, 18.11.2021, 26.07.2022, 23.08.2022, 29.09.2022 and 20.12.2022.

On previous hearing held on respondent PIO was directed to deposit the penalty and supply the pending information in connection with point no. 1 and 2 to the appellant, failing heih penalty will be enhanced but after the ample time has elapsed nothing is heard from respondent PIO. Last opportunity is awarded to him for the compliance of previous orders dated 23.08.2022 and 20.12.2022 within ten days after receipt of this order, failing which warrant will be issued.
- 5. A copy of this order be sent to the Commissioner, Municipal Corporation, Amritsar by name through registered post for compliance of this order.
