1. The RTI application is dated **7.12.2020** vide which the appellant has sought information:-

"Certified copies of Work Orders, Agreements and Sample Test Reports of all roads been constructed in Ward No. 94, Ludhiana since January 2017 till date."

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **11.1.2021** and Second Appeal was filed in the Commission on **20.5.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **21.11.2022**.

- 2. Both parties are present. As directed, the respondent PIO-cum-XEN, B&R, Zone A, MC, Ludhiana, has carried the original file pertaining to Sunil Nagar Part 2 and 3 and some partial record pertaining to Sunil Nagar Part 1.Copies of the same after due attestation have been handed over to the appellant. Regarding the missing file of Sunil Nagar Part 1, the respondent PIO-cum-XEN, Sh.Arvind Singh, is directed to initiate due process regarding said record and seek Orders from the competent authority for its reconstruction. This must be done within two months. A copy of the reconstruction record is to be handed over to the appellant.
- 3. Meanwhile, the appellant after examining the furnished information states that some documents (bills and map) in the copies of file provided of Sunil Nagar Part 2 and 3 are missing.
- 4. The PIO-cum-XEN, Sh. Arvind Singh has assured the Commission that all such documents as available in his record shall be provided to the appellant within two weeks. This Appeal Case is accordingly **Disposed of**.
