ORDER:

1. This order may be read with reference to the previous order dated 04.01.2023.
2. In today's hearing, the appellant states that nothing has been shown to him at the time of inspection and incomplete information has been supplied to him.
3. On this, Sh. Sanjeev, Senior Assistant states that the representative of the appellant, Sh. Sukhchain Singh visited their office for inspection but he did not give any submission to the respondent office after inspecting the same.
4. On this, appellant, Sh. Manjinder Singh denies the statement given by Sh. Sanjeev, Senior Assistant.
5. After hearing both the parties and going through the case file, it is observed that due to clerical error previous order dated 04.01.2023 was sent to the PIO & FAA, O/o Secy., RTA, Hoshiarpur instead of O/o Secy., RTA, Ferozepur, which may be read as Secy., RTA, Ferozepur.
6. Respondent PIO is directed to send the attested copy of requisite information to the appellant within 10 days through registered post under intimation to the Commission.
7. Appellant is advised to go through the information, once he had received and point out discrepancy within seven days in writing to the respondent PIO with a copy to the Commission, failing which it will be presumed that he has nothing to say in this regard.
8. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
9. This case is adjourned and both the parties are directed to come up on **06.07.2023 at 11:00 A.M. through CISCO-Webex**. Copy of the order be sent to the parties.
