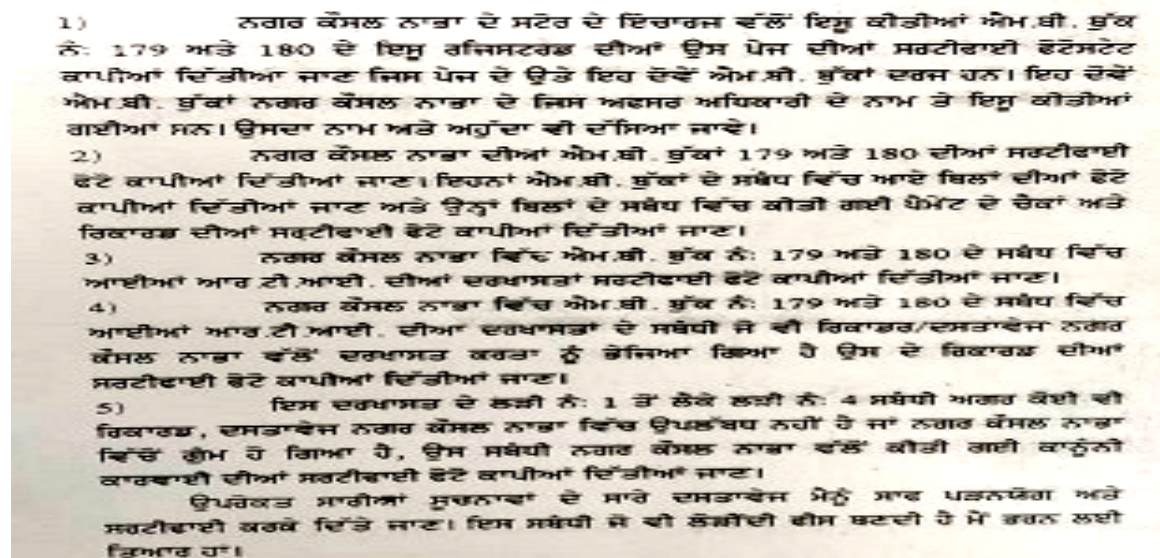

1. The RTI application is dated **21.5.2020** vide which the appellant has sought information:



as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **8.1.2021** and Second Appeal was filed in the Commission on **21.5.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **23.9.2022**.

2. Both parties are present. The respondent PIO-cum-EO, Sh. Aparapar Singh, has made a submission vide Letter No. 460 Dated 29.11.2022, that a reply to point no. 3 and 4, wherein requested information was denied as per Section 8(1)(j) of the Act, was sent to the appellant. The appellant has once again pointed out that point no. 1 which pertains to copy of the stock register regarding MB No. 179 and 180 has also been denied as “not available”.
