**ORDER:**

1. This case may be read with the reference of the previous order dated 01.11.2022 and matter was adjourned for today i.e. 25.01.2023.
2. In today's hearing, appellant states that the partial information has been supplied to them as the annexure were missing in relation to point number 02; in the supplied information.
3. On the other hand, the representatives of the department states that information as available in their official records had been supplied to the appellant. He further mentions that copy of information has also been sent to the Bench vide email dated 17.11.2022 and a hard copy of the same has also been sent to the Bench by post, which is seen and taken on record.

After having detailed discussion and examining the case file, the **appellant is directed to visit the concerned office on 30.01.2023 at 11:30 A.M** to the concerned PIO's office for inspection of remaining record relating to his RTI application **in connection with point no. 2**.
