In view of the above, a <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the PIO cum BDPO O/o Block Development and Panchayat Officer, Block Patran, District Patiala to explain as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
- 7. The PIO is directed to file reply to the Show Cause Notice and provide the requisite information to the appellant and should appear personally through CISCO Webex, on the next date fixed, failing which penalty will be imposed upon him as per provisions of the RTI Act, 2005.
- 8. The District Development and Panchayat Officer, Patiala is also directed to ensure compliance of the order from the concerned PIO, before the next date of hearing.
