- 5. In view of the above, a <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o Additional Deputy Commissioner (Development), Gurdaspur to explain as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
