**ORDER:**

1. The RTI application is dated 26.09.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 27.10.2022 and the second appeal was filed in the Commission on 19.12.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 01.03.2023. Accordingly, the case has been heard today. Shri Parveen Kumar, appellant comes present to attend the hearing through cisco webex.
3. Shri Amandeep Singh, AEE, Sub Division, PSPCL, Talwandi Sabo, District Bathinda comes present in person before the Bench to attend the hearing on behalf of the PIO. He states that the appellant has been supplied information vide letter dated 03.01.2023 by hand.
4. On the asking of the Bench, the appellant states that the document supplied does not contain the names of consumers and is unattested. The respondent clarifies that the document is system generated. Since the appellant wants the documents provided to be attested by the PIO, the same will be done although it is not required to be done for system generated documents.
5. In view of the assurance of respondent as given above, **the appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
