ORDER:

- 1. The RTI application is dated 1.11.2022 vide which the appellant has sought information as enumerated in his RTI application. The sought for information is with NIC. An email dated 13.07.2023 in this context has also been received from the respondent PIO, which is taken on record.
- 5. After hearing both the parties, the court directs the respondents to collect the information from NIC or write to it for supply of information to the appellant along with correspondence done with NIC in this regard under intimation to the Commission within ten days after receipt of this order.
- 6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
- 7. With the aforesaid directions, the matter is adjourned. To come up for hearing on 04.09.2023 at 11.00 AM before the Bench in Commission's office at Chandigarh. Copies of the orders be sent to the concerned parties.
