## **Appeal Case No. 2554 of 2022 (Video Conference Proceedings)**

enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **30.1.2022** and Second Appeal was filed in the Commission on **25.5.2022** under Section 19 of the Right to Information Act, 2005. The case was last heard on **23.8.2022**.

2. The appellant is absent but has informed the Commission that he is satisfied with the record shown to him at the inspection on 5.9.2022, as ordered by the Commission. The Commission notes that the RTI application has sought the status of the fire safety certification of various Government and privately owned commercial buildings, including schools and colleges.

3. The Commission is of the firm view that information regarding fire safety status of any building frequented by the public, should be in the public domain and must be available on the Website of the MC, Ludhiana.

4. The Commission impleads the **Commissioner, Municipal Corporation**, Ludhiana, and directs him to upload the Fire Safety status of all public buildings, both public and private on the official website of the Municipal Corporation Ludhiana. This must be done within three months of this Order under intimation to the Commission.

5. This Appeal is accordingly **Disposed of**.
