ORDER:

1. The RTI application is dated 23.05.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 09.07.2022 and the second appeal was filed in the Commission on 03.01.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. Shri Om Prakash, appellant states that partial information has been supplied to him.

3. Shri Satinder Singh, Inspector states that the information which relates to their Branch has already been supplied to the appellant and further mentions that the remaining information relates to other branches in the office of MC, Amritsar. He further mentions about a letter number 784 dated 20.02.2023, which has been received by the Bench vide diary number 5118 dated 22.02.2023, which is seen and taken on record.

4. Post deliberations, the Bench directs the Nodal Officer, Shri Pardeep Rajput, PIO –cum- Superintendent to look into the matter and make sure to supply the point wise attested copies of information (after collecting it from the concerned Branches) to the appellant along with a copy to the Bench before the next hearing. Shri Pardeep Rajput, PIO is also directed to appear in person along with the requisite information on the next date of hearing.

5. With the aforesaid directions, the matter is adjourned. **Both the concerned parties are directed to come up for hearing on 26.04.2023 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
