ORDER

20(1) proviso, thereto, for a personal hearing before the imposition of such penalty on the next

has nothing to say and the Commission shall proceed to take further proceedings against him ex-

parte.

8. With the aforesaid directions, the matter is adjourned. Respondent PIO is directed to come

up for hearing in person on 02.05.2023 at 11.30 AM before the Bench in Commission's

office at Chandigarh.
