ORDER

After hearing both the parties and examining the case file, it is observed that sufficient time has elapsed from the receiving of information but deficiency has not been pointed out by the appellant, which is a sheer wastage of precious time and resources of the Commission as it also affects the disposal of the case.

Appellant is advised o point out ambiguity in writing to the respondent PIO with a copy to the Commission by Monday i.e. 12.12.2022, failing which case will be decided on merit basis.
